1. Introduction

The important part of this chapter is the build up research model and description of research steps. In chapter 9, the author discusses the research results. I am very satisfied with using the hypothesis. All research results are discussed in high quality. The chapter 10 deals with contribution of the thesis to science and practice. The chapter 11 deals with conclusion. The list of used bibliography and publications is sufficient. In dissertation thesis is missing the part about possible implementation in practice and the retrospection of future research problems and goals.
