Overall thesis assessment and questions for the defence:

(Both the Master's thesis supervisor and reviewer present their questions.)

The student showed that she can understand the theme and therefore she described very well the theory of Working Capital using the literature sources in a correct way. This part of the Master's Thesis has a very high quality and the literature sources are also quoted correctly.

The student also showed that she is familiar with the Vietnamese Coffee Products market.

She described that the Gama Joint Stock Company has mainly two domestic customers and the size of the company is quite small. Furthermore the behaviour of that market is rather traditional — this generally determines both the potential results of the analysis described in the Master's Thesis and also the difficulties to implement these results into practice. Especially in the case, when the company would like to become the strongest and highly specialised. A question is whether the change of the business model would not be better to reach such a required status.

I highly appreciated the SWOT analysis which was made for both the Vietnamese Coffee Industry as well as for the company.

I am not sure that the student's recommendations made in the practical part would help much for the company to become stronger. The company maybe needs to change its profitability and its access to some long term investment sources which are needed for further development.

When describing the company's internal infomation the student changed the level of processing and also the level of the applied language. She should take a more professional approach to process a Master's Thesis. I missed some Tables and Figures described in the text (see for example pages: 66,77,81,89,92, ..), there are a lot of Abbreviations used in the text while these are missing in the List of Abbreviations (see p. 43,47,48, ...99).

Further some numbers in the Tables are missing the description of sources or formulas of how she reached them. The terminology used in the practical part should be more formal.

Some sentences occured twice in the same chapters (p. 53, 74).

Questions:

How is it possible that the Gama Joint Stock company reached a very low Sales volume in 2018 but the Profit was higher – were there any cost reduction measures taken by the management?

Why do we see different numbers in two attached Appendices for the same term of Net profit before Tax?
